## 1. Price bases <sup>1)</sup>

**1.1 Initial certification** **100 % of the basic price**

**1.2 Technical modification / prolongation** **60 % of the basic price**

- should a practical technical follow-up test in the laboratory or
- examination of design/drawings and approval exclusively by ECB be required
- Technical changes including a four-year extension (possible from six months prior to expiration of the certificate)

**1.3 Technical modification / prolongation** **30 % of the basic price**

- prolongation without changes (possible from six months before certificate expiry)
- if the application is received after the certification deadline, 100 % of the basic price will be charged

**1.4 Distributer-/License certificate** **30 % of the basic price**

### 1.5 Deviation in an individual case

ECB reserves the right to invoice based on actual cost. In individual cases, up to 100 % of the basic price may be invoiced in the cases described in 1.2 and 1.3 if extraordinarily high cost arise in connection with the evaluation and/or assessment.

### 1.6 Charges in the event of termination

In the event of premature termination for which ECB is not responsible, ECB reserves the right to invoice the services provided up to this point to the client. For that, a signed application for certification ECB•S C11 must be in place.

### 1.7 Advance payments

ECB is entitled to demand advance payments prior to or partial payments in accordance with the progress of the provision of services.
